British Columbia Institute of Agrologists is a regulatory body which establishes standards for the competent and ethical practice of agrology in BC.

OUR VISION

Through effective professional self-regulation, the British Columbia Institute of Agrologists and its Members shall be consistently regarded by the people of British Columbia as upholding and protecting the public interest.

OUR MISSION

The mission of the British Columbia Institute of Agrologists is to ensure the professional integrity and competency of its members to protect the public interest in the sustainable use of resources.

OUR MANDATE

As described in the Agrologists Act, the purpose of the institute is:

- 3. (2) (a) to uphold and protect the public interest by
- i. preserving and protecting the scientific methods and principles that are the foundation of the agricultural and natural sciences,
- ii. upholding the principles of stewardship that are the foundation of agrology, and
- iii. ensuring the integrity, objectivity and expertise of its members, and

(b)subject to paragraph (a),

- i. to govern its members in accordance with the Act and the bylaws, and
- ii. to cooperate with other professional or occupational bodies charged with governing the conduct or competence of their members on a matter the institute considers relevant to agrology.

RULES OF ORDER

The following rules of order are intended to facilitate progress, to include members of BCIA in orderly debate, and to ensure fairness and equity:

- The 2018 BCIA Annual General Meeting ("Meeting") shall be guided by, (in descending order of precedence), the Agrologists Act (SBC 2003 Ch.13) as amended from time to time, the current BCIA Bylaws("Bylaws") enacted as of January 1st, 2018, these Rules of Order, the current version of Roberts Rules of Order and historical practices of BCIA.
- 2. The current President of the BCIA Council shall serve as the Chair of the Meeting until the conclusion of the Meeting. If the President is unable or unwilling to serve as Chair then the next incoming President Elect (followed by the immediate Past President as the third option) shall serve as Chair. If that person(s) is unable or unwilling to serve as Chair the Members of BCIA in attendance at the Meeting entitled under the Bylaws to vote at the Meeting ("Members") may chose a suitable person to serve as Chair. The Chair is responsible for ensuring that all Bylaw obligations respecting the Meeting are satisfied. A decision of the Chair made during the Meeting can be challenged from the floor by way of a separate motion that requires 2/3rds plus one vote of the Members voting on that motion.
- 3. The Meeting shall be called to order by the Chair at the time specified in the notice of meeting and shall commence with a confirmation of the numbers of Members present and confirmation that the required quorum of at least 5% of the total number of voting Members of BCIA are present at the Meeting. Debate must be germane to the motion which is on the floor.
- 4. The business conducted at the Meeting shall include:
- adoption of the agenda of the Meeting;
- adoption of the minutes of the previous annual general meeting;
- adoption of the audited annual financial statements;
- appointment of auditors;
- receipt of Council election results (introduction of new Councillors and President Elect);
- debate and consideration of any properly submitted Resolutions including a determination of the annual membership fees and;
- any other business specified in the notice of the Meeting or the agenda as approved by the Members.
- 5. The Meeting will be conducted at a level of formality considered appropriate by the Chair for a meeting of professional persons. Members are obliged to act with tact, decorum, courtesy and respect in debate with fellow Members and shall keep their comments relevant to the issue(s)under consideration.
- 6. Only practicing Members in good standing are eligible to speak, make motions, and vote upon any motion put forward at the Meeting. Members who wish to speak will approach a microphone, wait to be acknowledged by the Chair, and open by stating their name and BCIA Branch. The Chair may alternate between proponents and opponents to a pending motion. All voting shall be by a show of hands unless a

recorded vote is required by the Bylaws, called for by the Members in attendance by a duly passed motion, or determined by the Chair as required as the vote is too close for accurate determination. The Chair is entitled to vote on any motion but only to break a tie vote.

- 7. Other than standard administrative motions only motions that were provided to the Registrar of BCIA at least 31 days prior to the date of the Meeting as included in the written notice of the Meeting shall be introduced, debated and voted upon at the Meeting.
- 8. The Member making a motion should speak first to the motion. Members may not speak more than twice to a motion. The Chair shall recognize Members, generally in the order of Members identifying a desire to speak to a motion. On each issue or debatable motion, each member will be entitled to speak up to two (2) times, for no longer than three (3) minutes each time. Speaking a third time or longer than 3 minutes will require permission from the assembly. To speak a second time on the same issue or to ask an additional question on a report, a Member must wait until all other Members who wish to speak on it for the first time have spoken. Members must direct their comments to the Chair and not to the mover or seconder of the respective motion.
- 9. Once the question has been stated by the Chair, it belongs to the assembly as a whole, and may only be modified or withdrawn through permission of the assembly via
- appropriate motions (e.g. to amend) or
- the initial motion maker requesting and obtaining consent of at least 2/3rds plus one vote of the Members voting to withdraw the respective motion.
- 10.A motion to amend a motion requires the permission of both the mover and seconder of the original motion. If permission is not obtained the original wording must be the motion that is voted upon.
- 11. A majority vote of 50% plus one vote of Members voting on a motion will decide all motions excepting those matters in the Bylaws or as outlined in these Rules that require a higher level of approval. The Chair shall, on votes of all motions, ask for and record the number of Members who wish to abstain from a vote, however the number of abstentions shall not be counted in a determination as to whether a specific motion has been passed by the Members.
- 12. A vote on a motion shall be taken when discussion ends but any Member may during the course of debate, move a motion for an immediate vote (close debate/"call the question") which, if carried by at least 2/3rds plus one vote of the Members voting on the motion, shall end discussion and the vote on the main motion shall then be taken with the main motion subject to the standard 50% plus one vote majority rule. The Chair may also close the debate by asking, "Are you ready for the question" and if there is no desire for further debate, the Chair may put the motion to a vote.

RULES OF ORDER

CONT'D

- 13. A motion to amend a main motion may be amended, but subsequent amendments will not be allowed except for minor wording changes with such changes to be allowed at the discretion of the Chair. If further amendments are desired, the outstanding amendments will first be decided by vote, and depending upon the outcome of the vote on the amendment(s), motions may be offered to amend the amended motion or original motion as the case may be.
- 14. A motion to refer to a committee, postpone, or table may be made with respect to a pending main motion, and if carried shall set the main motion (the initial proposal) aside.
- 15. Once a motion has been carried that specific motion/topic will not be entertained again during the same Meeting.
- 16. The adjournment of the Meeting requires a duly seconded motion passed by the voting Members present at the Meeting.

The 70th Annual General Meeting of BCIA was called to order at 9:11am by President Jennifer McGuire, P.Aq.

Elisabeth Deom, P.Ag. was identified as the Parliamentarian for the meeting. Elisabeth highlighted the Rules of Order as outlined in the AGM edition of the newsletter. Eligible voting members in attendance were confirmed – 173 total. Quorum was confirmed.

1. Adoption of Agenda

Motion was made to adopt the agenda. *Motion carried.*

2. Adoption of 2016 AGM Minutes

Motion was made to adopt the minutes as presented. *Motion carried*.

3. President's Report

Jennifer McGuire, P.Ag. called for a moment of silence in memory of deceased Institute members Rod Negrave and Philip Jones. Jennifer referenced her report on page 7 of the AGM newsletter and highlighted a few items. The hiring process for the Executive Director position was shared, with JP Ellson being announced as the new BCIA Executive Director. He will take his position early July, 2017.

Jennifer thanked all volunteers and especially the BCIA staff for the extra work they have done this past year; thanked the members for their patience in the transition of Executive Directors; and thanked Don Rugg, P.Ag. for acting as the Registrar during the transition.

The Election Review Committee was recognized for their work and recommendations, which set a clearer path for this year's election, and also the development of the Nominations Committee.

Terms of Reference for all Committees were revised and approved with the goal of consistency and clarity. The Finance Committee was removed as it was viewed as overlapping with the Executive Committee. The Nominations committee was developed as a way to help with recruiting of volunteers both at the Council and at the Branch level.

4. Acting Registrar's Report

Don Rugg, P.Ag. referenced his report on page 8 of the AGM newsletter and highlighted a few items. Don gave an overview of 2016 stats with new memberships. Thank you to staff for the work and efforts while in the position.

5. Follow-up to 2016 Resolutions

President Jennifer McGuire, P.Ag. stated that no resolutions were passed at the 2016 AGM and no resolutions were received prior to the 2017 AGM though Jennifer noted two action items that were requested of Council: 2016 AGM Q & A document regarding finances and 2016 Election Review document. PRESIDENT'S REPORT

Wow, what a year this has been for BCIA!

This has been a year of building, engaging and reinvigorating. This Summer we welcomed a new Executive Director, JP Ellson, from Saskatchewan, to our team. We also created a new position of Deputy Registrar which our long-time employee Laurena Olsen is now filling. We reviewed and compiled "What Was Said" material from over 20 meetings and 250 members regarding the updating of our strategic plan.

When Council hired JP, we knew we had plotted a course for accelerated improvements to our internal processes in BCIA. This winter has seen a much needed in depth update to our Bylaws and our committee terms of references. We now have Human Resource Manual and Policy documents, as well as Investments and Financial Policies in place. This may all seem a bit tedious but its essential to continuity and meeting our responsibilities as an employer and professional organization.

When I volunteered for this role, I had imagined clarifying branch and provincial roles, improvements to the conduct and discipline process, as well as some bylaw cleanup. I never saw the Professional Reliance Review coming, but I have come to appreciate what that process is doing for professionals in the natural resource sectors in BC. Now Council spends more of its time discussing what it looks like to enhance public trust, not just spreading the word that there are Agrologists, but also helping to build an understanding of our competencies and the ethics we bring to the job. This has been a quick turnaround process, putting plenty of strain on staff and volunteers. A special thank you to Brian Mauza and his amazing record keeping and historical perspective. His help to our Executive Director has been very valuable this year.

This spring I was fortunate enough to attend the Alberta Institute of Agrologists AGM and I was amazed at their speaker, topics and overall meeting delivery. GREAT JOB and hats-off to our neighbours to the East. Thanks to their openness and transparency, a couple of BCIA members were able to participate in an onboarding session for their councillors, enabling us to see the Carver Model of governance being effectively utilized. BCIA hopes to bring this style of governance to the forefront in the years to come. Council hopes to enhance our transparency and effectiveness regarding policy that guides our Executive Director. This is an exciting next step for Council to effectively direct what needs to be done while empowering our staff to decide how best to get it done.

One of the most interesting aspects of the Alberta Institute of Agrologists AGM, was a Thursday morning bear pit where they discussed in detail the work that is going into providing greater clarity of what requirements of a professional are needed in order to declare a scope of practice. Richard Dixon from the University of Alberta also spoke and provided a splash of cold water for professional organizations that we had better get it straight - that our role is to protect the public. How the guidelines put in place to enable this impact the professional is less of a concern than how effective that direction is in protecting the public. It has become increasing obvious that BCIA will need to revisit our 38 Areas of Practice in the future to provide clarity as to what exactly Agrologists do and what is in our Areas of Practice and what is not. Council is discussing launching a Professional Reliance Committee to help with discussion arising from the review. If you are interested in volunteering let head office know.

It has been a tricky year, as many of us volunteers are learning, un-learning, and relearning what is the appropriate level of guidance to our staff. I thank all the volunteers who spend endless hours helping our organization maintain its high performance. A special shout out to our Committees who work very tirelessly whether its on Bylaw updates, developing public outreach videos or reviewing credentials for new members it all takes volunteer time. **THANK YOU.**

EXECUTIVE DIRECTOR'S REPORT

Executive Director/Registrar/In House Legal Counsel Report 2018

As I near the end of my first year with BCIA I am pleased with the tremendous progress we have made. Over this first year we have been able to revise or enact numerous foundational pillars upon which we can build a stronger association moving forward.

Over the course of the year I have attended/participated in the annual meetings or strategic planning sessions in 7 of our 8 Branches. I have seen the tremendous diversity in our membership which is united by a common passion for the responsible use of the resources of British Columbia. I have also attended the AGMs of other resource sector professions including the professional engineers, foresters, applied technicians, and biologists as well as our partner agrology institute in Alberta.

Due to the selfless dedication of Council members and numerous Committee volunteers we have:

- enacted a complete revision of our Bylaws;
- launched our first social media communication activities;
- revised or designed Terms of Reference for all of our Standing Committees;
- instituted a complete updated set of human resource policies;
- enacted a new expedited
 P.Ag. registration program for
 experienced yet new agrologists;
- rejoined Agrologists/Agronomes Canada (after a two year absence) thereby bringing our eligibility requirements more in line with national standards;
- enacted a new 5 year Strategic Plan after one of the most extensive membership consultation process I have ever been involved with.

In addition, in the capacity of in-house legal council I investigated and/or provided all relevant information to the Conduct Review committee for determination respecting all 6 disciplinary matters that were outstanding when I assumed the Executive Director position in July 2017 (as of the date of this AGM not all matters have been fully resolved however the process is finally moving forward after a significant period of dormancy).

Looking forward to the remainder of 2018 there are two continuing initiatives that will occupy a significant amount of my attention that being the Professional Reliance Review ("PRR") and the related question of "Right to Practice". The PRR may be the most significant development in the profession of agrology in BC since the enactment of the Agrologists Act in 2003. BCIA has participated in this initiative since August 2017 and we are fortunate to have Jennifer McGuire speaking at this AGM to assist us in adapting to the new milieu.

The PRR has generated two related initiatives, the first of which is a much higher level of cooperation between the 5 professions engaged in the responsible development of British Columbia's resources (i.e. APEGBC, ASTTBC, ABCFP, and CAB). There has developed an informal coalition between agrologists, biologists, technicians, foresters and engineers manifested in bi-monthly meetings during which issues and challenges of common interest are discussed. This aspect has developed to the point that we are discussing a more formalized coalition structure.

The second initiative is the consideration of what is known as the Right to Practice. Currently, BCIA members have Right to Title which basically means that persons cannot identify themselves as professional agrologists unless they are members of BCIA. Right to

Practice (different versions of which are enjoyed by the engineers, foresters, and technicians of British Columbia as well as Saskatchewan and Alberta agrologists) in simplistic terms means that persons cannot do agrology work at all unless they are members of BCIA. I am looking forward to the workshop I am hosting at this AGM at which we can discuss the ramifications of this possible development.

I would be remiss, if not completely lost, were it not for the support of our staff Laurena Olsen (in her new position of Deputy Registrar) and Bonnie Keleher. Their patience and understanding have been a crucial element in achieving all of the work we have completed over the past year. DEPUTY REGISTRAR'S REPORT

A fter three months on an interim basis, I was officially appointed to the position of Deputy Registrar January 1, 2018. Since that time I hit the ground running with an influx of applications. Working directly with the Credentials Committee I now oversee the application review process ensuring that our applicants meet the minimum requirements for membership. In addition, I develop enhancements to the A.Ag. program and initiatives to promote increased membership in the BCIA.

I have carried over many administrative functions of applications and registration of memberships duties from my previous position and have increased cooperation with our 8 Branch executives. I work closely with those Branches to ensure orderly operation of the A.Ag. program, and oversee advancement of our A.Ag. Members to full professional status. Engaging with the public, educational institutions and BCIA Members, I help promote the benefits of membership in a professional organization. As Deputy Registrar I perform all these duties under the direction of the Registrar, JP Ellson, who is also responsible for the complaint and discipline process.

My years with BCIA have brought great personal and career growth and I am grateful for the opportunities BCIA has availed me. Great friendships have been formed and much appreciation of late goes to my co-worker Bonnie Keleher for her patience and guidance, Don Rugg, P.Ag., previous ED/Registrar who has been a great mentor over the years and our new ED/Registrar for his direction and oversight on the many positive changes the Institute has been engaged in. A huge thank you goes to the members of the Credentials Committee who volunteer their time reviewing applications and participating in face to face meetings during the year.

Highlights from 2017

Our total membership as of December 31, 2017 came to 1596 with regulated members (A.Ag.'s and P.Ag.'s) making up the bulk at just under 1300 members.

2017 was a banner year with 109 applications received with 22 being from new graduates of educational programs taking advantage of the reduced application fee for those that apply within six months after graduation. We had the most student members ever with 71 on the Register at year end.

103 new Members were placed in the A.Ag. program and introduced to the 8 different Branches around the province. Mentors are always needed to guide these new Members through the A.Ag. program, introducing them to the Institute at the branch level and provincial level. If you are keen to mentor a budding agrologist please contact the A.Ag. Coordinator of your branch to put your name forward.

There were 71 A.Ag.s who advanced to P.Ag. status and will receive their certificates to display prominently to their peers and the public confirming that they have attained the status of Professional Agrologist with the rights and privileges that come with that title.

BCIA continues to move toward gender equity with approximately 45% of our 2017 membership being female. This statistic compares very favourably with other professions in the province.

Moving Forward

The entrance requirements into BCIA were revised early in 2018 to be more aligned with national standards. The Credentials Committee and staff work closely together to maintain awareness of educational trends and areas of expertise in which Members of BCIA may practice.

Council recently approved a new initiative proposed by the Credentials Committee - the Expedited P.Ag. Admission program. Professionals who have the required educational requirements and work experience may now be eligible for immediate full membership within BCIA. The program allows qualified individuals to expedite the required articling program by having certain elements of the standard articling term waived. Upon approval the applicant will immediately receive their full P.Ag. designation on the condition that the applicant meets certain membership duties and responsibilities. We hope this new program will assist gualified individuals with employment opportunities and advancements.

The A.Ag. program has had some additions as well, with program elements added based on the commencement date of the new A.Ag. Member. These additions are aimed at increasing networking and professional opportunities and compelling new Members to better acquaint themselves with their respective Branch activities.

The BCIA website has a wealth of information. I urge you to explore the different features available to you as a Member including resources and Council documents for your reading enjoyment.

COMMITTEE REPORTS

COMMUNICATIONS COMMITTEE

2017 has proven to be a year of change and challenges for the Communications Committee as we have worked closely with Council to clarify our role and function. Now that this has occurred we are now enthusiastically proceeding to meet these goals and timelines.

Some things of note are the establishment of two \$1,500.00 BCIA scholarships, one is for full time undergraduates and one for postgraduates. The criteria include an appropriate field of study along with a 300 to 500 word essay on agrology which will be evaluated by this committee. This replaces the former \$400 award which was limited to UBC. These more financially meaningful scholarships will be available to all appropriate post secondary institutions in BC and are planned to be available for the 2018 Fall semester.

Another initiative is the use of social media. This has been under discussion with Council for some time as the pros and cons to the BCIA were investigated. I am pleased to report that Council has approved the concept and Facebook and LinkedIn are both now live and the links are on our website. We are now exploring ways to utilize this media to increase the profile of the BCIA through concepts such as ads or contests with modest prizes.

As was mentioned in last year's report, 2 videos were under production. The first one has now been released for viewing on our website. Many thanks to the BCIA members who volunteered their time to be part of the video and to Alpha Omega Productions of Kamloops for their professional work!

Also under review is the raising of both the BCIA's and the Branches profile though the offering of financial/trophy awards in appropriate school science fairs and the support of organizations such as 4H. More on this later.

In closing I would like to sincerely thank the dedicated committee members Rhonda Maskiewich P.Ag., Sarah Fennel P.Ag., Kim Hancock P.Ag., Eryne Croquet P.Ag., our Council rep. Kevin Eastwood A.Ag. as well as BCIA staff.

GOVERNANCE COMMITTEE

The Governance Committee's activities continued on a very industrious pace. Our primary goal in 2017/2018 was to undertake a complete review of our Bylaws. Our work commenced last March and concluded with the committee's submission of recommended Bylaw amendments to Council later in the year. The initial goal was to bring them up to date, review and standardize terminology, eliminate vague wording and make the Bylaws easily understood. As well, we worked closely with the Conduct and Discipline Committee (now the Conduct Review Committee) on Bylaws related to the complaint and disciplinary processes. In November, Council added their amendments and called for comments from members in December. The Governance Committee submitted their response and further suggestions

to Council along with other members in early December.

The second goal of the Governance Committee was to review and make recommendations to a committee of Council regarding Council and Council member evaluations, and a proposed "Council Charter". Those recommendations were submitted. This work is still in progress as of early April.

The third goal for the Governance Committee was to write the Terms of Reference for the new Nominations Committee. Subsequently, Council undertook to standardize the Terms of Reference for all the standing committees. The Governance Committee was then asked to review the amended terms for reference for all the standing committees of the British Columbia Institute of Agrologists.

In late November, the Chair of the committee was asked to assist the BCIA office to prepare for the Professional Reliance review being conducted by the Province of BC. This included review of all the background material and reports as well as assisting in the preparation of BCIA's responses and participating in the 5 hour audit review.

At this time I would like to acknowledge our Committee members who dedicated their personal time and much of it on a tight timeline. Thank you. Your dedicated service exemplifies the ethics of a professional Agrologist.

CREDENTIALS COMMITTEE

S ince the last AGM and Credentials Committee report, the committee has been very busy. We received 109 applications in 2017 – a record number of applications reviewed by the Credentials Committee in a year. For the first quarter of 2018, 38 applications were received which again broke a record for applications received in a quarter. With the large increase in applications, we have been fortunate to have another person join the committee. Theresa Loewen joined us at the beginning of the year and has done a great job of keeping up with the applications and has hit the ground running.

In addition to Theresa, I'd like to thank Vafa Alizadeh, Geneve Jasper, Ruth McDougall, Andrea Mah, Jessica Morgan, Margot Pittaway and Martin Sills for volunteering even more time this year to help keep the committee operating quickly and efficiently. I don't think any of us expected such a large increase in applicants so their extra work has been appreciated greatly. Exciting news for Margot as she welcomed a daughter to the world recently and as of writing, Andrea is expecting to have a baby of her own any day. Thank you to both of them for their commitment to the profession and to BCIA as they now take a leave from the committee for the short term.

Since January of last year up until April 1, 2018, BCIA received a total of 147 new applicants, with most of them being approved as Articling Agrologists. Four applications were rejected and 4 applicants withdrew their applications. Nine applicants were given conditional approvals whereby they need to complete additional educational requirements prior to becoming active as a member. Given the volume of applicants, Ruth McDougall's project of reviewing degrees last year as a pre-screening tool has been put to very good use.

We had two face to face meetings over the last year. Both were very productive, much of the work involving the discussion of unusual or complex applications. Several new ideas or initiatives were discussed and some came into fruition such as the revised entrance requirements for membership with BCIA that came into effect January 1, 2018. With the ongoing development of National Entrance Standards by Agrologists/Agronome Canada for the profession of Agrology, the acceptable subject matter for foundational courses was expanded and the number of agrology courses was increased, by 5 extra courses. An Expedited P.Ag. Admission program was discussed and now has been approved by the Council. Also in effect now are additions to the A.Ag. program whereby program elements have been added that will provide our newly accepted members increased networking opportunities. Other items to note are that the committee terms of reference were revised and approved and the A.Ag. term length 2 vs 3 years was discussed but at this time will not change.

On behalf of the committee, we would like to thank Laurena Olsen, Don Rugg and JP Ellson for their support this past year. We couldn't have done our jobs without their assistance.

AUDITORS REPORT

To the Members of British Columbia Institute of Agrologists

Whereas the Agrologists Act [SBC 2003] CH.13, grants the BCIA Council the authority to make Bylaws governing the operation of BCIA and the profession of Agrology within the province of British Columbia; and

Whereas Section 13(3) of the Act requires Bylaw amendments respecting the election of Counsellors by the Branches to be ratified by the membership of BCIA at a duly constituted meeting of the membership; and

Whereas the Bylaws enacted by the BCIA Council on January 1st, 2018 amend, modify, or affect the election of Branch Councillors as outlined below;

"65. Councillors from Branches shall be elected as follows:

(a) for terms of office commencing in even years, one Councillor shall be elected by each of the Fraser Valley, Victoria and the Islands, Peace River and Vancouver Branches;

(b) for terms of office commencing in odd years, one Councillor shall be elected by each of the Okanagan, Kamloops, Kootenay Boundary, and Cariboo Central Interior Branches;

(c) for all terms, elections shall be held no earlier than October 1 of the year prior to the year in which the term of office is to commence and no later than one week prior to the Institute's annual general meeting of the year in which the term of office is to commence.

66. Each Branch shall determine its own procedures for the election of its Councillor that ensure:

Ratification of Bylaw Amendments respecting temporary vacancies in the Councillor, President and President Elect positions

Whereas the Agrologists Act [SBC 2003] CH.13, grants the BCIA Council the authority to make Bylaws governing the operation of BCIA and the profession of Agrology within the province of British Columbia; and Whereas Section 13(3) of the Act requires Bylaw amendments respecting the temporary appointment of persons to fill vacancies in Councillor, President and President Elect positions to be ratified by the membership of BCIA at a duly constituted meeting of the membership; and

Whereas the Bylaws enacted by the Council of BCIA on January 1st, 2018 amend, modify, or affect these aspects of the Bylaws as outlined below;

"72. If a vacancy occurs in the office of President, the President-Elect becomes the President for the unexpired term of the vacancy. If the President-Elect is unable or unwilling to fill the vacancy or if the office of President-Elect is vacant, Council shall fill the office temporarily by a majority vote of Council and then call for a ballot of all Members to select a President.

73. If a President-Elect fills a vacancy in the office of President, the President-Elect shall complete the unexpired term of the President who was replaced and continue to serve as President for the term for which the Members elected the President-Elect.

RESOLUTION #2 (Cont'd)

74. If a vacancy occurs in the office of President-Elect, Council shall temporarily fill the vacancy of President-Elect with a Member which shall be chosen by a majority vote of Council and then call for nominations to select a new President-Elect. The call for nominations shall be provided to all voting Members within 30 days of the appointment of the temporary President–Elect with the election to be completed no later than 75 days from the date of the temporary appointment.

75. If a vacancy occurs in the office of a Councillor elected by a Branch, upon consultation between Council and the respective Branch Executive, the Branch Executive shall fill the vacancy by election or by appointment for a term equal to the remaining term of the previous Councillor who had vacated the position."

RESOLUTION #3

Ratification of Bylaw Amendments respecting the election, duties, terms in office and removal of Councillors, President and President Elect of BCIA

Whereas the Agrologists Act [SBC 2003] CH.13, grants the BCIA Council the authority to make Bylaws governing the operation of BCIA and the profession of Agrology within the province of British Columbia; and

Whereas Section 13(3) of the Act requires Bylaw amendments respecting the election, duties, terms in office, and removal of Counsellors, the President and Vice President (known in BCIA as the President Elect); to be ratified by the membership of BCIA at a duly constituted meeting of the membership; and

Whereas the Bylaws enacted by the Council of BCIA on January 1st, 2018 do amend, modify, or affect these aspects of the Bylaws as outlined below;

Election of President-Elect

64. The President-Elect shall be elected as follows:

(a) A Member may not nominate themselves for the position of President-Elect.

RESOLUTIONS FOR PRESENTATION AT 2018 AGM

(b) By no later than 4:00 pm Pacific Time on January 15th of even numbered years only, a Member nominating another Member as a candidate for the position of President-Elect must deliver to the Registrar a complete nomination package in writing (delivery by electronic means is acceptable), which must include the following:

(i) the signature of the candidate indicating their consent to the nomination;

(ii) the signatures of five (5) additional Members in good standing indicating support for the nominee and their consent to release their names in support of the candidate; and

(iii) a brief biography of the candidate (750 words maximum) including:

a. background information on the candidate;

b. a description of the skill set the candidate would bring to the position;

c. a photo suitable for circulation to Members; and

d. a statement of reasons why the candidate seeks the office e of President-Elect and what their priorities would be for the Institute.

Except as required by law the above information will be the only information released to Members by BCIA about the candidate in regards to the election. Any additional information or electioneering shall be conducted in strict accordance with the Code of Ethics.

(c) The Registrar and the Nominations Committee must review and validate all nominations by January 30, 4:00 pm Pacific Time of the year in which the election is to be held.

(d) If the Registrar receives only one valid nomination, the Registrar, with agreement of the Nominations Committee, shall report to Council that no ballot is required, and Council shall declare the candidate elected by acclamation.

(e) If the Registrar receives more than one valid nomination, the Nominations Committee shall advise Council that a Returning Officer must be appointed by February 15, 4:00 pm Pacific Time of the year of the election. The Returning Officer will carry out the balloting in accordance with these Bylaws.

(f) Notwithstanding anything contained herein Council may, by a motion at a duly constituted meeting of Council, extend the time limits for receipt of nominations and conduct of an election of a President-Elect.

Terms in Office

69. Commencing with the 2018 Annual General Meeting the President-Elect shall serve for four (4) years, beginning at the close of the annual general meeting in the year of their election and ending at the close of the fourth annual general meeting after their year of election, as follows:

(a) year one, as President-Elect;

(b) year two and three, as President and;

(c) year four, as immediate Past-President.

Removal from Office

80. Any Councillor deemed to be in contravention of the Act, Bylaws, Code of Ethics, Council Charter of Conduct and/or Council conflict of interest policy, other than Councillors appointed under to Section 8(2) or (3) of the Act, may be removed from the Council by resolutions at two successive meetings of Council, providing the resolutions are each approved by at least two-thirds of the Councillors present at the time each vote is taken. A Councillor subject to removal pursuant to this provision shall be provided at least 14 days notice of the intention to vote for their removal, and will be afforded an opportunity to address the Council meeting before the vote occurs.

81. A Councillor who is elected by a Branch may be removed from office by resolutions at two successive properly called meetings of Members of that Members' Branch, providing the resolutions are each approved by at least two-thirds of the Members present at the time each vote is taken.

Duties of Officers

President

84. The President shall preside at Institute meetings, Council meetings, and executive committee meetings.

RESOLUTION #3 (Cont'd)

President-Elect

85. The President-Elect shall assume the duties of President in the President's absence or at the request of the President, and (a) shall be a Member of the Executive Committee and; (b) shall assume additional duties at the request of the President or Council.

Immediate Past-President

86. The immediate Past-President shall be a Member of the Executive Committee (for a one year term only as outlined in these Bylaws), and shall assume duties at the request of the President or Council."

Now Be It Resolved that Sections 64, 69, 80, 81, 84, 85, and 86 of the BCIA Bylaws enacted on January 1st, 2018 are hereby ratified by the membership of BCIA.

Increase in BCIA Annual Membership Dues

Whereas the Agrologists Act [SBC 2003] CH.13, grants the BCIA Council the authority to make Bylaws governing the operation of BCIA and the profession of Agrology within the province of British Columbia; and

Whereas the annual membership fee has not been increased since 2012 during which time the annual expenses required to operate BCIA have increased to a point that BCIA has accessed its financial reserves to operate for the last three fiscal years; and

Whereas BCIA has limited financial resources to engage in any new activity related to the new Strategic Plan or meet increased expenses that may be implemented as a result of the Professional Reliance Review 2018; and Whereas the Council of BCIA on November 24th, 2017 passed a motion "To implement a dues increase of \$50 for P.Ag.'s and A.Ag.'s as of January 1, 2019."; and

Whereas Section 13(3) (c) of the Act requires Bylaw amendments respecting the amount of the annual membership fee to be ratified by the membership of BCIA at a duly constituted meeting of the membership.

Now Be It Resolved that the motion of BCIA Council dated November 24th, 2017 respecting an increase in the annual dues for all P.Ag and A.Ag members of BCIA is ratified.

Background Information for Dues Increase Request - Resolution #4

1.Annual membership dues were last increased by \$50 as of January 1st, 2012. Presently there is a motion from Council asking the membership to approve a \$50 annual increase in the membership dues effective January 1st, 2019. There has not been increase in other fees charged by BCIA (i.e. late fees, application fees, etc.) for a similar 7 year period if not longer.

2.Since the last dues increase the percentage of expense to revenues has consistently increased to the point that

the 2018 fiscal year represents the 3rd consecutive year in which BCIA is running a deficit budget. Part of the 2018 deficit is attributable to the initial enactment of some aspects of the new Strategic Plan such as the rejoining Agrologists Canada with an annual cost of approximately \$14,000. Financial reserves have been used to meet these deficits but that is not a sustainable course of action.

3.It is probable that BCIA will be expected to engage in additional activities commencing in 2019. The provincial government has already indicated that it may exercise its legislative power to appoint up to 3 lay persons to the BCIA Council. This will increase the costs of the Council meetings. It is also assumed that BCIA will be mandated to increase its Members understanding of the cultural issues of indigenous peoples and strengthen the enforceability of its professional development requirements. It is also possible that there will be additional obligations placed upon BCIA by the final PRR which is due to be delivered before the AGM. If that scenario

CARIBOO CENTRAL INTERIOR

ell another year has passed and what a year it has been !! I showed our CCI Branch boundaries to the manager of the Cariboo Fire Center and he estimated that within our branch area over one million hectares of timber was lost to the firestorms. The economic impacts are truly staggering with our agricultural sector being hit particularly hard with losses to their structures, fences, livestock, feed stacks, and cultivated pastures. Range as well as the larger operations have lost much of their private timber which means their ability to access cash is deeply diminished. However, the ranching community is very resilient. That combined with the \$20 million federal/provincial AgriRecovery fund for 2017, they'll come back but it will be a long road.

These same wildfires also impacted our branch in that there were few professional development (PD) events. PD is very important as the BCIA's branches main function is the nurturing of A.Ag.'s through mentoring and PD exposure. There were 4 PD events, a Smithers Yard Crawl hosted by William Elliot P.Ag. and Ryan Holmes P.Ag., John Stevenson P.Ag. gave a presentation on Change and Opportunity in Agriculture in Northwest BC and Lila DeLury P.Ag. hosted the Symphony of Soils video in Vanderhoof and an extremely informative session in Prince George on Conducting Better Business Meetings with a focus on Robert's Rules of Order. CCI Executive continues to discuss ways to significantly increase the number and diversity of PD events and the challenges faced by the physical size of our branch area.

FRASER VALLEY

The Fraser Valley Branch had a very successful full and eventful year in 2017, beginning with our AGM on January 28th, which is held at the site and time of the Pacific Agricultural Show in Abbotsford. We welcomed seven new P.Ag.s into the Branch at the AGM. As well, recognition was given to long term members: Orlando Schmidt received a 25-year pin, and both David Ormond and John McFaul received 50-year pins. Congratulations!

Much of the attention of the Executive for the first half of the year was planning and hosting the Institute's May 9-12 Conference and AGM in Abbotsford. The planning committee and BCIA staff organized a wonderful and successful conference. Thank you once again to all the volunteers who contributed to making the 2017 Conference and AGM a memorable experience.

The year also welcomed new members onto the Executive. Colin Stewart took on the role of Treasurer, Linda Wilson as President-Elect and secretary, and Caroline Bedard as the PD Coordinator. Scott Miles continued his job as the Articling Agrologist Coordinator. Our Executive would not have been as good as it was without the contributions of Directors, Parashar Malla and Art Guite. Dawn Ross continued as Councillor for the second year of her term.

The FV Branch offered a full slate of professional development opportunities with six events hosted. The first PD event was a lunch hour talk on June 7th, 2017 in Abbotsford. Two Regional Pesticide Officers from the Pesticide Compliance Program presented on the different roles of the Pest Management Regulatory Agency/Health Canada. Some of the topics covered were the Pest Control Products Act, special reviews triggered by other countries, compliance activities, incident reporting, and risk assessments.

The second event was an afternoon session on June 8th at the same location in Abbotsford. Dr. Jason Deveau, Application Technology Specialist, discussed methods to reduce off-target contamination, appropriate delivery of grower education, challenges emerging with fast changing technologies, and development of relevant educational materials and communication methods. The event was offered in person and by webinar. On September 12th, the FV Branch organized a tour of the United Flower Growers Co-operative Association (UFGCA) auction. Members from the Fraser Valley Branch and Vancouver Branch were taken behind the scenes for a 2-hour long visit led by Mr. Bob Pringle (CEO), while this reverse auction was in full swing. This is the largest of its kind in North America. The Dutch-style auction and online Floral Market Place provide BC floral products to retailers and wholesalers in Western Canada and the United States. Most buyers are bidding on flowers and bedding plants remotely via the UFGCA's online system. Growers bring their products in through the night, until 5:30 am. This spot market allows local growers to sell off extra crops.

Turf management was the topic of the October event. Twenty participants attended multiple presentations at the Burnaby Mountain Golf course. A panel of local experts gave presentations about pest management, environmental issues, by-laws, impact of climate change/ water restrictions, pesticide availability, misconceptions about golf and its impacts, and education efforts. The City of Burnaby and the Western Canada Turfgrass Association surprised us by treating the group to tasty snacks and lunch.

November 4th saw the annual joint event with the Vancouver Branch. Sixteen Fraser Valley Branch members attended the full day mini-conference on resourcebased legislation, including the Water Sustainability Act, Wildlife Act, Land Act, Riparian Areas Regulation, and enforcement of these regulations.

The final PD event for the year was a Holiday PD and Networking Event on November 29th at Krause Berry Farm and Estate Winery in Langley. It was a fun evening of networking and fellowship; a perfect event to end the year. The Branch Executive acknowledges the efforts and commitment of Caroline Bédard as PD Coordinator, and other agrologists who assisted with the PD events. Well done!

The Fraser Valley Branch welcomed 10 new Articling Agrologists into the program, with a total of 26 active Articling Agrologists at the end of 2017. Three Articling Agrologists completed their program requirements in 2017 and were awarded Professional Agrologist status.

AGROLOGIST OF THE YEAR

Perry Grilz, P.Ag.

Agrologist of the Year Award is to recognize and pay tribute to an Agrologist who has made a significant contribution to British Columbia agriculture, natural resource and environmental science.

About Perry Grilz, P.Ag.

The 2017 fire season was the worst in BC history. Perry stepped forward and played a vital leadership role for the agriculture and natural resource sectors during the event. Perry made many contributions in areas such as: connecting with and representing the livestock sector, providing consistent high quality leadership to FLNRO & RD staff throughout the event, proactively engaging in strategic recovery related activities both during the response and recovery phases of the event.

Perry's ties to the agriculture industry began during his early years spent on the family farm in central Saskatchewan. At



the University of Saskatchewan Perry pursued a Bachelor of Science in Land Use Planning and a Master of Science in Plant Ecology. After university Perry began his career in his home province in a

number of positions in restoration and ecology before moving to BC where he became the Ministry of Forests Northern range Reference Areas Specialist. In this position, Perry established a network of range enclosures throughout the northern portion of the province. This important work continues to be a valuable resource for range staff today. Perry was promoted to Operations Manager in the Prince George Forest District where he developed a pilot approach in response to the mountain pine beetle epidemic mitigating impacts to range tenure holders. His work influenced the Range Program's response to this crisis throughout the province. Perry went on to become Associate Director of range Branch, overseeing branch operations for eight years before moving into his current role as Director of Range Branch.
