The following rules of order are intended to facilitate progress, to include members of BCIA in orderly debate, and to ensure fairness, equality and common sense:

- The meeting will be run in accordance with the provisions of the Agrologists Act ("the Act"), the BCIA Bylaws ("the Bylaws"), and the current edition of Robert's Rules of Order Newly Revised.
- Only Institute members in good standing are eligible to speak, make motions, and vote.
- Members who wish to speak will approach a microphone, wait to be acknowledged by the chair, and open by stating their names.
- On each issue or debatable motion, each member will be entitled to speak up to two (2) times, for no longer than three (3) minutes each time. Speaking a third time or longer than 3 minutes will require permission from the assembly.
- To speak a second time on the same issue (or to ask an additional question on a report), a member must wait until those who wish to speak on it for the first time have spoken.
- Debate must be germane to the motion which is on the floor. The chair may alternate between proponents and opponents to a pending motion.
- Debate on a motion may be closed by unanimous consent, or – if unanimous consent is not evident – by a motion to close debate (such a motion is presented from a microphone and cannot interrupt a person who was recognized to speak).

WHAT IS THE **PURPOSE OF** THE BCIA?

The purpose of the institute is:

- to uphold and protect the public interest by
 - preserving and protecting the scientific methods and principles that are the foundation of the agricultural and natural sciences,
 - upholding the principles of stewardship that are the foundation of agrology, and
 - ensuring the integrity, objectivity and expertise of its members, and
- subject to paragraph (a),
 - to govern its members in accordance with the Act and the bylaws, and
 - to cooperate with other professional or occupational bodies charged with governing the conduct or competence of their members on a matter the institute considers relevant to agrology.

WHAT IS AGROLOGY?

"Agrology" means using agricultural and natural sciences and agricultural and resource economics, including collecting or analyzing data or carrying out research or assessments, to design, evaluate, advise on, direct or otherwise provide professional support to

- the cultivation, production, improvement, processing or marketing of aquatic or terrestrial plants or animals, or
- the classification, management, use, conservation, protection, restoration, reclamation or enhancement of aquatic or terrestrial ecosystems that are affected by, sustain, or have the potential to sustain the cultivation or production of aquatic or terrestrial plants or animals.

These updates bring all members with access to email onto the same page with proposed bylaw revisions or policy updates, and they allow us to effectively ensure that branch activities as well as PD opportunities are shared with everyone. The information included may not be relevant to all but it is always relevant to some, solidifying the importance of the updates. Many thanks to the staff who continue to get these email updates out to our members.

Communication from Council to the branches has steadily increased as well through the regularly scheduled Branch Presidents' calls. Gone are the days where the only source of communication with council was

through your councillor. This was an initiative brought to fruition through our Executive Director/Registrar, Bob Moody, and the outgoing Past President, Rob Kupchanko. Many thanks to both of them for continuing to set the BCIA up for success. On a personal note, I would like to thank Rob for his continuous counsel, advice, and support.

As always, any issues, comments, questions or concerns brought forward from our members are addressed. Do not ever hesitate to contact the BCIA office, because increased communication can never lead us astray.

EXECUTIVE DIRECTOR & REGISTRAR'S REPORT

The BC Institute of Agrologists continued to make significant progress on many fronts and in many areas of interest to our members throughout 2014. This also holds true for the early months of 2015.

We are experiencing steady growth in the number of registered Professional Agrologists and are seeing an increase in the number of new applications. In fact, a new record for applications was recently set during the first quarter of 2015. In addition, we now have the highest number ever of student members, an increase of 50% over the long term annual average, and we expect the number to be even higher by year end. Although we expected a positive response to the 2014 AGM resolution to eliminate the annual fee for student members beginning in 2015, we were a bit surprised to see the flood of student member applications so early in the year.

Elsewhere in this newsletter, the Chair of our Communications Committee, Marg Crowley, describes the process that was followed in the development of the new BCIA logo. Council felt that it was very important to obtain the endorsement of the membership with the new logo. Excellent feedback was received through a member poll and a resounding majority of 80% of the respondents viewed the proposed new logo favourably. Our new website is presently undergoing testing and will be available for use by our members when it is fully operational.

2014 was the first year for the increased branch subsidies from BCIA. Last year the per capita subsidy provided to each branch increased to \$30 per branch member, up from the previous figure of \$20 (where it had been for many years). A record number of Professional Development events occurred last year and it was especially gratifying to see so many more PD opportunities made available to individual branch members



throughout the province. In my mind the 2014 Land Summit was one of the most outstanding PD events of the year and I am very pleased to report that the Land Summit Society (of which we are a founding member) subsequently sent us a cheque for \$20,000 as our share of the profits from the conference.

Last year also saw the completion of two new professional courses for our members. Angela Westmacott, our legal counsel, developed a new course entitled "Professional Negligence and Regulatory Offences" and a webinar recording of her presentation of the course material is now available for viewing on the member side of our website. The course is now mandatory for all new Articling Agrologists accepted after March 1, 2015. We have plans to make the second course entitled "Governance of Professional Conduct" available in a similar format before long.

In the interests of transparency and accountability to our members, Council decided last year to have both our annual operating budget and the Audited Financial Statements posted to the website. You will see from the two

documents that we continue to enjoy a very favourable financial position.

The Agrologists Act 2003 states that the purpose of the institute is to uphold and protect the public interest. One way we do this is through our complaints process and last year I received two complaints from the public. I am pleased to report that both complaints were resolved through mediation as provided for under Bylaw 117 of the Complaint Procedures. This outcome is another first for BCIA.

In closing I hope that you will be able to attend our 2015 AGM and Annual Conference in Kelowna this May. I also hope you will avail yourself of the many opportunities to become actively involved with your professional body in 2015. It is only through the dedication of our many volunteer members that we will be able to maintain the momentum of striving for excellence that we have attained in recent years. Thank you all for your ongoing support of BCIA, together we are making a difference.


COMMUNICATIONS COMMITTEE

he Communications Committee met this year by teleconference, e-mail, and one face-to-face meeting to discuss communications initiatives, other issues such as social media, and to generate ideas. I would like to thank the members — Cindy Hall, P.Ag., Alex Koiter, P.Ag., Regan Purdy, P.Ag., Howard Ratzlaff, P.Ag., and Bob Moody, P.Ag., ED/Registrar — for their commitment and thoughtful comments and ideas over the past year. I also thank Laurena and Bonnie in the BCIA office for their patience, help and support this past year.

It has been a busy year for communications initiatives for the BCIA – as reported in previously, the BCIA Council embarked on a full redevelopment of the website - to refresh its look – and to improve the functionality so our hard-working staff are able to handle the increased workload in a much more efficient manner, including online registering.

Along with updating the website, we have been developing a new logo and tagline, which will be formally revealed at the AGM in Kelowna. Changing a long-held logo and brand is a serious matter — our current logo having been in use for 25 years. The 2-year long process started with considering

many various options, from different shield looks, fonts, acronyms, figures, modern and abstract graphics, and narrowing these down to a few options. Then Council and the Communications Committee reviewed these to narrow them further.

It was important to ensure that the membership was part of the process hence the survey held in March. Over 37% of the membership responded to the survey on a potential logo concept and I would like to thank the members for your many thoughtful responses. A breakdown of the survey results are shown in the chart below at left. The finalist option (below) for a logo concept received an overwhelmingly positive response of 80.3% - a pretty good indication that we were on the right track.

CREDENTIALS COMMITTEE

would like to start off by thanking the Credentials Committee members for their commitment and hard work throughout 2014 and into 2015. The Committee membership for 2014 consisted of Alec Drysdale (Chair), Vafa Alizadeh, Andrea Cowgill, Margot Pittaway, Martin Sills and our newest addition Stewart McBride. Welcome Stewart!

I am acting as Chair of the committee for a six month term while Alec Drysdale is away on medical leave. His strength and tenacity is inspiring and our thoughts are with him and his family during this challenging time.

In 2014 we reviewed 88 applications, 12 were rejected and one was withdrawn. 11 of the 88 applications were from recent graduates.

We had a productive face to face meeting in July 2014 where we discussed application requirements including types of post-secondary education, foundational hard sciences, term reductions, areas of practice, and managing course shortfalls. Key outcomes from the meeting were: applicants must have a 4 year bachelor's degree and are required to complete an Academic worksheet in addition to the standard application form identifying the courses they have taken that meet our requirements; and Articling term reductions require 2 of the 6 years of continuous agrology experience post-graduation must be in

It is important that we attract students and recent graduates who will, hopefully, start with us early in their careers and stay with us for a long time. In keeping with that we have also implemented changes to the application fee structure for recent graduates and student members. In January 2014, the recent graduates application fee was reduced by half and has had a strong uptake. Similarly, the student member fee was eliminated on January 1, 2015 and we are receiving a similar response and we now have the highest number of student members in **BCIA** history!

In addition, in 2013, the PPC began exploring avenues to ensure a tangible and effective connection with the BCIA membership.

I had the privilege of chairing the PPC this year. In this capacity, I was fortunate to work with a very professional and dedicated team. I would like to express a heartfelt thank you to each and every committee member who has shared his or her time, patience, expertise and good humour with us throughout the year.

Highlighted Activity

I am proud to highlight some of the work that occupied the PPC's time this year, including:

- Advancing the development of the "Climate Change and Professional Development Responsibilities for Agrologists in British Columbia" position paper,
- Drafting the Protocols for Reporting Deficiencies Identified
